| <b>①</b>  | <b>FILL OUT THE MOTION AND ORDER:</b> Fill out the entire motion and order, except leave the date and signature line blank on the Order for the judge to sign. The amount of the bond is contained in the letter you received from the Clerk's Office. If you have lost this letter or need to know the amount of the bond, please contact the Clerk's Office at 602-506-7757 to receive this information.  |   |   |
| <b>②</b>  | <b>MAKE TWO (2) COPIES:</b> After you have filled out the motion and Order make two (2) copies of each document.  |   |   |
| <b>③</b>  | <b>FILE ORIGINAL MOTION WITH CLERK OF THE SUPERIOR COURT:</b> File the original motion with the Clerk of the Superior Court, Civil File Counter and ask the Clerk to stamp the two copies. After you receive the Order either mail or deliver the certified Order to the Clerk of the Superior Court, Financial Services Division, Cash Bond Disbursements, Plaza Level at 201 West Jefferson, Phoenix, Arizona. 85003.
